

## **GREENWOOD TOWNSHIP**

**July 7, 2014**

### **Approved Minutes**

Lester Vida, supervisor, called the meeting to order at 7:00 pm and led with the Pledge of Allegiance. Board members, David Lawrence, James Korman, Linda Bailow and Barbara Ferrett, were all present. There were also 14 visitors present. A motion to accept the agenda with the addition of Barb Ferrett's MTA report was made by Dave Lawrence/Jim Korman. M/C.

### **Community Reports**

Karen Lipovsky, county commissioner, gave her monthly report including that the commissioner's will begin working on the budget next week.

Nancy House gave her monthly library report along with the usage report and roof repair progress. She handed out the schedule for computer classes at the library.

Nick Loomis gave an update on the progress of the new Greenwood Township web site. Things are now moving forward and he has taken more pictures to add to the web site. He will be working with Barb and Linda to get everything updated and corrected.

Ken Lind, insurance representative, reported that the township policy is up for renewal and that there is an approximate \$100 increase. He talked about funds available from the DNR if we happened to have a master plan to add a park or rec area at the township hall.

Barb Ferrett gave the June local MTA report.

A motion by Dave Lawrence/Barb Ferrett to accept the minutes of the June 2, 2014 meeting was made. M/C.

A motion by Jim Korman/Barb Ferrett to accept the treasure's report as present was made. M/C.

### **Unfinished Business**

The hall painting is complete and looks good. Jim Korman and Lester Vida have tried calling the county and state about road signs for the Amish buggies but have had no luck. They will continue to try to get information on getting signs. Once we get signs they may be able to post them on the township signs that are already up.

A final hearing to close the books on URAA will be July 29 at the Gladwin County Courthouse.

### **New Business**

A resolution was read and accepted by the board for a Credit Card Policy. A motion by Linda Bailow/Dave Lawrence was made to pass the resolution. M/C.

Questions have come up about having a headstone on graves prior to a person's passing. It has been found in the past that people have had a headstone put on a grave and have moved and that there is no way to contact anyone about a headstone and we had grave sites that could not be used. The board has decided to stay with the present policy of no headstone prior to death unless the person(s) is willing to sign a disclaimer.

A motion by Jim Korman/Dave Lawrence was made to accept the contract for the 2014-2015 propane contract with Heintz Propane for the township hall. M/C.

Discussion of selling the old tables in the storage room for \$20 each or best offer. The board agreed that the tables should be sold and possibly look into buying some new tables in the future.

### **Public Comment**

There were comments that the hall looks really nice since it was painted. Question asked if any of the township roads have been graveled yet, not as of yet. Question was asked what is being done on Lily Lk. Rd. New gas lines were being installed to replace the old ones.

A motion by Dave Lawrence/Jim Korman was made to pay the bills. M/C.

A motion was made by Linda Bailow/Dave Lawrence to adjourn. M/C. Meeting adjourned at 7:00 pm.
